As soon as possible but at latest within 12 months after recieving the goods, otherwise the right of claim may become lost in accordance with transport legislation/conventions. IMPORTANT INFORMATION

If the goods are damaged, or goods are missing, do not sign for the goods without making an annotation on the consignment note or similar. Regardless when the damage/deficit has been noticed, and even though remarks were made on the consignment note, always send a written notice of loss to the carrier.

In a case of visible damage, the notice of loss shall be made immediately when receiving the goods.

In cases of concealed damage:

Sea transport at the latest 3 days after receipt
Air transport at the latest 14 days after receipt
Rail transport at the latest 7 days after receipt
Road transport at the latest 7 days after receipt
